# EXTEND RUNWAY AND TAXIWAY AT OERLAND AIRBASE, NORWAY

# 1. Background

Norwegian Defence Estates Agency (NDEA), on behalf of the Government of Norway, hereby invites firms from NATO member nations to participate in the two competitions for the refurbishment and extension of the runway and parallel runway at Oerland Airbase, Norway.

These two competitions have been published through the European TED database system, which allows firms from most NATO member nations to compete.

At its meeting on 7 July 2015 and on the basis of document AC/4(PP)N(2015)0057, the Investment Committee "at 28C-F" agreed NCB+ as the procurement method. With this notification Norway would like to ensure that firms from all NATO member nations are informed and allowed to participate in the competitions.

## 2. Scope

The runway extension programme will be described in two separate Invitation for Bid (IFB) documents with the intention to sign two separate contracts:

One IFB document will cover the structural civil works involved in the refurbishment and extension of the runway and parallel runway:

- Removal of the existing concrete runway end
- Establishment of new base layer for the runway and parallel runway extension including drainage works
- Provision of asphalt layer and concrete layer for the extended runway and parallel runway
- Re-asphalting of the remaining part of the runway
  - Relocation of the existing arrestor gear system
- Marking
- Relocation of perimeter fence
- Relocation of roads and adjoining aprons as required

The other IFB document will cover relocation and refitting of electrical and electro technical systems:

- Runway and parallel runway lighting - new lighting to be provided

- Approach lighting existing lighting to be partly reused
- Power and signal cabling including earthing in support of the scope described above

The total estimated cost is EUR 32 Million exclusive of VAT.

4. Security Issues

Both IFB documents will be classified NATO RESTRICTED. The firms who intend to participate in the bidding must therefore provide to Norwegian Authorities a security evidence proving that the firm is eligible to store and handle classified documentation up to and including NATO RESTRICTED. All persons involved in the bidding process must have a valid NATO Certificate of Security Clearance covering NATO RESTRICTED.

The successful bidder, with which a contract will be signed, will be required to have staff involved in the execution of the contract having a valid NATO Certificate of Security Clearance covering at least NATO RESTRICTED. The management and other key staff which will work at Oerland Airbase during the execution of the contract must hold a valid NATO Certificate of Security Clearance covering at least NATO CONFIDENTIAL level.

5. Timelines

The IFB documents are expected to be issued during second half of August 2015. Bid Closing Date will be announced in the IFB documents.

The contract works are scheduled to start at site during January 2016 and must be completed by 1 August 2017.
